

Minutes of the 9th Annual General Meeting

The President, Dr Shek Chi Chiu, called the Meeting to order at 6: 35 p.m. A total of 11 full members of The Hong Kong Neonatal Society attended the meeting in person and 7 other members via ZOOM.
